    - Volunteer position's on hold.

    - 3F28 in service. Has corrosion and deterioration of the 2" tubing securing the rear bumper to the frame. Mitch has been given an estimate; however, Mitch states this week sometime of rain hold off. I still believe that going through him is the best and least expensive mode of repair. We will continue to be diligent in getting this repair done.
    - Truck -1 hydraulic line was leaking due to not being tightened properly during last repair. Banner Fire repaired this at no charge.
    - U-1 is expected to have a possible blown head gasket. Clouser Automotive is repairing. More to follow.
    - Also the ac unit is operative, possible electronic issue. Should be repaired by Clouser's.
    - GTSi will be here later this month to begin troubleshooting the radio system problem with the base station.
    - Banner fire will be out in June to size the new members for gear.
