

**ORDINANCE NO. 24-03**

**AN ORDINANCE AMENDING CHARGES AND FEES FOR EMERGENCY AMBULANCE SERVICE FOR CHATHAM COMMUNITY FIRE PROTECTION DISTRICT**

**WHEREAS**, the Chatham Community Fire Protection District has heretofore established certain charges and fees for emergency ambulance service, Ordinance 07-CFPD-03, dated July 10, 2007, as amended by Ordinance 07-CFPD-05, dated February 12, 2008; further amended by Ordinance 09-CFPD-16, dated March 23, 2010; further amended by Ordinance 12-CFPD-04, dated March 13, 2012; Ordinance 13-CFPD-3, dated September 10, 2013; further amended by Ordinance 16-CFPD-03, dated July 14, 2015; and further amended by Ordinance No. 16-CFPD-11, dated June 1, 2017; and further amended by Ordinance No. 19-CFPD 03 dated August 27, 2019, and further amended by Ordinance No. 23-CFPD-01 dated February 22, 2023

**WHEREAS**, the Board of Trustees finds that the charges as originally established and previously amended require adjustment so as to properly reflect a more appropriate charge for services and which will more closely reimburse the District for its actual costs and expense of operation for the services themselves and also help in defraying the overall cost of maintenance of emergency ambulance service in the District;

**NOW, THEREFORE, BE IT ORDAINED** by the Board of Trustees of the Chatham Community Fire Protection District as follows:

**Section One:** The provisions of Ordinance No. 07-CFPD-03 are hereby affirmed in their entirety with the exception of Section Three and Section Four thereof which deal with the Charges for Services. The Charges for Services are hereby amended effective January 1, 2025 upon the passage of this amending Ordinance as follows:

(a) The charges for an ambulance and personnel shall not exceed a rate for residents within the jurisdiction of the Chatham Community Fire Protection District of the following:

- A. \$1070.99 + \$21.00 per loaded mile for an ALS2 transport
- B. \$976.57 + \$21.00 per loaded mile for an ALS transport
- C. \$892.76 + \$21.00 per loaded mile for a BLS transport

(b) The charges for an ambulance and personnel for nonresidents living outside the jurisdiction of the Chatham Community Fire Protection District shall not exceed a rate of the following:

- A. \$1,479.99 + \$21.00 per loaded mile for an ALS2 transport
- B. \$1376.57 + \$21.00 per loaded mile for an ALS transport
- C. \$1292.76 + \$21.00 per loaded mile for a BLS transport


**Section Two:** The provisions of Ordinance No. 07-CFPD-03 shall otherwise remain in full force and effect with the exception of the charges for services for residents and nonresidents, which provisions are superseded by the terms and provisions of this ordinance.

**Section Three.** Effective Date. This Ordinance shall be in full force and effect after its passage and approval by the Board of Trustees.

**Section Four.** Severability. In the event that any section, clause, provision, or part of this Ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect.
