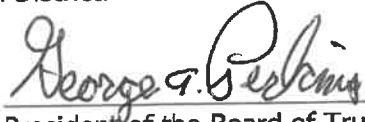

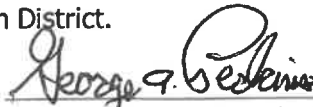

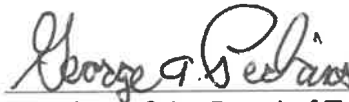

ORDINANCE NO. 25- 06

TAX LEVY ORDINANCE
CHATHAM FIRE PROTECTION DISTRICT

AN ORDINANCE LEVYING TAXES FOR ALL PURPOSES FOR CHATHAM FIRE PROTECTION DISTRICT, SANGAMON COUNTY, ILLINOIS, FOR THE YEAR 2025, TO BE COLLECTED AND PAID IN 2026

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE CHATHAM FIRE PROTECTION DISTRICT, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: There is hereby levied and assessed upon all taxable real property situated within the corporate limits of the Chatham Fire Protection District, a public Fire Protection District organized and existing under the Illinois Fire Protection District Act (70 ILCS 705/0.01 et seq.) as a unit of local government under Article VII, Section 7 of the Illinois Constitution of 1970, and which is duly authorized by law to levy taxes for corporate, insurance, firefighter pension, and ambulance purposes, and located in Sangamon County, Illinois, the total sum of

Five Million Two Hundred Fifty-One Thousand Nine Hundred Fifty-Two Dollars (\$5,251,952.00)

which said amount shall be raised by taxation upon all taxable assessed real property according to its value, as same is assessed and equalized for State and County purposes for the year 2025, and which said sum is to defray the expenses of the Chatham Fire Protection District for the fiscal year June 1, 2025 through May 31, 2026.

SECTION 2: That the amount levied is to defray the expenses of operating the Chatham Fire Protection District, as provided by the Annual Budget and Appropriation Ordinance passed by the Trustees of the said Fire Protection District, approved by the President of the Board of Trustees and attested by the Secretary of the Board of Trustees of the said Chatham Fire Protection District, and, thereafter, duly published in the manner required by law, which said Budget and Appropriation Ordinance is now on file with the Secretary of the Chatham Fire Protection District and is in full force and effect and which levy amounts shall be apportioned and applied among the several purposes for which said appropriations are made in the proportion that each budget item bears to the total amount appropriated for each respective fund as follows:

SECTION 3: The Secretary of the Chatham Fire Protection District shall file a Certified Copy of this Ordinance with the County Clerk of Sangamon County on or before the date provided by law for so doing, and when so filed, same shall operate as a Certificate of the amount needed by the Chatham Fire Protection District to be raised by taxation as aforesaid and the County Clerk of Sangamon County shall ascertain the rate percent upon which the total of all property subject to taxation within the corporate limits of the Chatham Fire Protection District, as same is assessed and equalized for State and County purposes, will produce a net amount not less than the amount directed to be levied as set out above and shall extend such taxes upon the books of the collector responsible for the collection of real estate taxes in the Chatham Fire Protection District, subject only to any rate limitation applicable to each specific levy set out above.

SECTION 4: That if any section, division, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such findings shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.

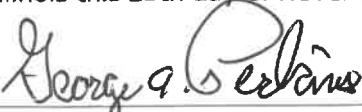

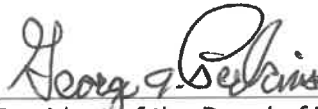
